Singapore's meetings, exhibitions, and conventions industry's back to business and in full swing.

And it was a show of confidence on 31 August 2022 when nearly 900 leaders from small and medium enterprises and industries specializing in sustainability gathered for the SME Centre Conference 2022 at the Marina Bay Sands Convention Centre.

Organized by the SME Centre at the Singapore Indian Chamber of Commerce and Industry and Enterprise Singapore, the half day conference was graced by Minister of State for Trade and Industry, Ms. Low Yen Ling.

SICCI's Chairman, Mr. Neil Parekh, gave the opening address.

The Conference looked at how businesses could navigate the future of sustainability and harness opportunities in this space while contributing to Singapore's green transition.

In her wide-ranging address, MOS Low announced that small and medium enterprises (SMEs) in Singapore can now tap on a first-of-its-kind mentorship programme that will make it easier for them to kickstart their sustainability journeys and build capabilities to decarbonize.

Known as the "SME Kickstarter Decarbonization Programme", it is supported by Enterprise Singapore (EnterpriseSG) under the Enterprise Sustainability Programme (ESP).

"I was happy to announce that as part of Enterprise Sustainability Programme, Enterprise Singapore is collaborating with Schneider Electric on a decarbonisation programme for SMEs. This SME Kickstarter Decarbonisation Programme will link SMEs with experts who will help them set up decarbonisation targets, access energy efficiency services and take actionable steps to reduce energy use and emissions. SMEs will be able to actively monitor their energy consumption, as well as use energy efficient solutions to reduce business costs and become sustainable in the long run. In addition, I shared that companies from food services, food manufacturing and retail sectors can apply for the Energy Efficiency Grant from tomorrow onwards, 1 Sep 2022", explained Ms. Low.



In his speech, Mr. Neil Parekh noted that according to a recently concluded UOB SME Outlook Study 2022, three in five SMEs in Singapore believe in the importance of incorporating sustainable practices in their businesses.

Added Mr. Neil, "With plans for Singapore to reach zero carbon emissions by 2050 and the Singapore Green Plan 2030 already underway, the trade associations and chambers, as well as SME Centres, are taking the first steps to create more awareness amongst SMEs of the training programmes ad solutions available for sustainability practices. We will play a critical role in facilitating sustainability journeys for SMEs".

The theme for this year's conference was Navigating the Future of Sustainability.

Participants also visited an exhibition held as part of the conference.

From ethically and sustainably designed homewares to smart vending machines for orange juice and sustainable ceramic tiles, these were just some examples of "green" projects by our very own SMEs that were on display.

Said MOS Low, "Kudos to Singapore Indian Chamber of Commerce & Industry for successfully hosting this year's Conference, and a special shoutout to SME Centres and Enterprise Singapore for their continued support for our SMEs".

Speech by MOS Low Yen Ling at the SME Centre Conference 2022



Mr. Neil Parekh, Chairman, Singapore Indian Chamber of Commerce and Industry

Distinguished Guests, Ladies and Gentlemen

A very good morning to all. I would like to start by thanking the Singapore Indian Chamber of Commerce and Industry (SICCI) for inviting me to this year's SME Centre Conference. This is my third time taking part in this annual event. After two years of attending the conference virtually, I am delighted to be here at this conference in person.

The SME Centre Conference is an excellent platform for SMEs to exchange views and share ideas on how to grow, transform, and capture new opportunities. On this note, I would like to extend my heartfelt gratitude and appreciation to all our 11 SME Centres, our hardworking Business Development Advisors and of course, colleagues at Enterprise Singapore for their continued support for our SMEs throughout the pandemic. It has been a very difficult two and a half years. And of course, all the Chambers of Commerce, especially SICCI for making today's conference possible.

Companies will need to embrace sustainability to remain competitive

In the last two and a half years, our SMEs have shown great tenacity and resilience in adapting and transforming, and many rose to the occasion. Our SMEs, micro-enterprises included, found new opportunities to pivot and grow even amid the crisis. There is a Chinese saying 危机中总有奇迹; there are always opportunities amidst a crisis. When discussing micro-enterprises, a topic very close to my heart, for instance, is shopkeepers in the heartlands who have digitalised and gone online. Three years ago, would you have imagined that more than 88 per cent of HDB shops would offer e-payments. But today, 88 per cent, close to 90 percent, of our HDB shops offer e-payments, and over 65 per cent of them have digitalised, either through e-commerce or digital solutions. And I think some of you would have seen the shopkeepers selling their products and services via a "live" stream.

As we move into the post-pandemic era, SMEs would do well by spotting new opportunities in the green economy. You would all agree that the green economy presents opportunities not only to big organisations, but also to smaller SMEs. Indeed, the green economy is a new area which beckons with a bright horizon. Climate change concerns are

spurring governments, businesses and consumers to place greater emphasis on reducing carbon footprint and becoming more sustainable. This has opened up fresh possibilities for growth. To expand your revenue stream, introduce new products, and capture a wider consumer base.

To that end, in February last year, we launched the Singapore Green Plan. The Singapore Green Plan 2030 has set concrete and ambitious targets to help Singapore move towards a greener future. It will open doors to promising new areas, for example, green finance, carbon services and sustainable tourism. The theme for this year's event – "Navigating the Future of Sustainability", is therefore very apt and timely.

We hope our SMEs will tap on sustainability as a new avenue of growth. Let me elaborate on why it is compelling for enterprises, big and small, to come on board. Using a word we are all familiar with - "eco", or the letters E, C and O.

"E" is for "environment". I think we would agree that the weather we experienced in August alone, the first two weeks of August, was very hot. And the third and fourth week of August, the heavy downpour reminded us of the year-end season. It was unprecedented. As the world seeks to protect our environment from further damage and climate change, SMEs can take the chance to also get into the act and make sustainability part of their business practices, part of their business model and their revenue model.

"C" stands for "competitive advantage". To me, going sustainable is not adding cost. We should see it as a competitive advantage. Going green can be a competitive advantage for your company as an early mover in this emerging sector.

c. "O" in 'eco' stands for "opportunity". Getting into the sustainable space will open new growth opportunities for you, your staff and your company in the green economy.

Each of you today plays a pivotal role in Singapore's green transition and how we can make this green transformation work for Singapore. We want to assure you that the Singapore Government, not just MTI but the whole of government, including MSE, MOT etc., are all very committed to the Singapore Green Plan 2030. The Government will spare no effort to support and help our SMEs stay competitive and relevant as we move towards the green economy.

The Government will support SMEs as we navigate the future of sustainability

To this end, the Government has launched a robust range of support schemes and measures to help our SMEs embrace sustainability and be part of this emerging green future. We do so because we recognise that SMEs need an extra boost to get help them embark started. To on sustainability journey, Enterprise Singapore has launched the Enterprise Sustainability Programme (ESP). I remember joining Minister Gan Kim Yong on 1 October last year, where he launched the \$180 million ESP which provides targeted support for companies.

a. For instance, SMEs that are new or in the early stages of their green journey can start by building your awareness and knowledge of sustainable practices. For example, you can attend subsidised training courses organised for local companies by Enterprise Singapore in partnership with Global Compact Network Singapore, PwC Singapore, and the Singapore Environment Council. We have worked with them to curate courses to help our SMEs.

b. In the area of funding, which is very important, SMEs can also tap on additional support, such as the Enterprise Financing Scheme – Green, to access financing for capability-building projects or new sustainable solutions.

I am happy to share that since the launch of the ESP in October last year, more than 300 local SMEs have participated in awareness and education programmes. More than 40 sustainability-related projects are being developed, with the support of Enterprise Singapore. This is a very well thought-through and curated support scheme. To me, level 1 is to support our enterprises. We also support our TACs (Trade Associations and Chambers), for sectoral-focused areas. We also take an ecosystem approach to focus on certification, financing and training.

It is not just the big SMEs that are well-equipped to come on board. No matter your size, and whether you think you are ready to, do approach the SME Centre that is in your vicinity. We have 11 centres and very committed business development advisors. One company which has benefitted from the ESP is Yeap Transport. Yeap Transport is a local private bus operator. Yeap Transport has undertaken a climate strategy and footprint study to measure its scope 1,2 and 3 carbon emissions. It has also developed a sustainability roadmap to help

the company achieve net zero carbon emissions, for example, by turning its bus fleet electric.

As our SMEs go green with more sustainable practices, we are also giving them a helping hand. The recently launched Energy Efficiency Grant provides SMEs from the food services, food manufacturing and retail sectors funding support to adopt energy-efficient equipment for their business, which can reduce their overall running costs. I addressed this in a parliamentary question at the August Parliament Sitting; we have chosen to start off with food services, food manufacturing and retail because, looking at their expenses, energy costs comprise a significant proportion of that. And we want to help bring business costs down and help them to embrace and adopt energyefficient equipment. Eligible companies can apply for the Energy Efficiency Grant from tomorrow, 1 September.

I am happy to announce that as part of ESP, Enterprise Singapore is collaborating with Schneider Electric on a decarbonisation programme for SMEs. This initiative will link SMEs with experts who will help them set decarbonisation targets, access energy efficiency services, and take actionable steps to reduce energy use and emissions. All very practical issues and problem statements to solve. We hope that through this SME Kickstarter Decarbonisation Programme, SMEs will not only actively monitor their energy consumption but also use energy-efficient solutions to reduce business costs and become more sustainable in the long run.



SME Centres will continue to support the growth and transformation of all enterprises

Helping our SMEs continue to grow and flourish is a network of 11 dedicated SME Centres located all over Singapore. Besides providing business advisory services, these Centres also focus on boosting the capabilities and skills of our SMEs, including micro-enterprises. In 2021, the SME Centres assisted over 28,000 SMEs to improve and meet their business needs despite the challenges of COVID-19. There was a lot of focus on helping our micro-enterprises and SMEs to adopt sustainability standards and implementing sustainability projects through the ESP.

Furthermore, under the Partners for Business Growth (PBG) pilot programme, more than 100 SMEs were supported in their growth journey as they set new goals and implemented new projects, including those involving sustainability.

I would like to highlight two SMEs that have successfully incorporated sustainability as part of their PBG programme. One of them is Long Pun Enterprise. Long Pun Enterprise is a 40-year-old plastics and products manufacturer in the construction industry. With the help of Business Development Advisors (BDAs) from the SME Centre@SMF, Long Pun incorporated sustainability into its business strategy. This has led the company to expand its product range into providing clean energy solutions like energy storage systems and flexible solar panels to the construction and landscape industry.

Another company that grew its sustainable offerings with the help of the PBG, is Sheldon Global, the home and lifestyle company behind local brands such as HOUZE and Table Matters. With the advice of BDAs from the SME Centre@SICCI, Sheldon Global automated its ecommerce workflow and used Robotic Processing Automation to enlarge its sales capacity. As business leaders, you would know that if you can enlarge your sales capacity, you are well placed to grow your top line and bottom line. The company has created a new line of eco-friendly homeware called ecoHOUZE, which is well-received by consumers.



On behalf of MTI, congratulations to Long Pun and Sheldon Global on your green progress! A big thank you to our 11 SME Centres and our hardworking BDAs who work alongside our SMEs to enable them to overcome the adversity in the last two and a half years and to grow and expand their business. We plan to launch the official PBG programme in 2023. Meanwhile, I encourage SMEs to sign up for PBG - to explore and capture the exciting potential of the green economy.

I want to assure you that the Government is committed to seeing our SMEs grow in Singapore and beyond. Who says that our small HDB shops and micro enterprises will only cater to business in the domestic market? I cited in Parliament in March Heng Foh Tong, which is a traditional shop that sells herbal tea. They have come on board e-commerce and are now selling their products to 10 countries. Whether it is digitalisation or sustainability, these are two very important growing trends that we must seize to help our SMEs grow their top line and bottom line and, at the same time, to future-proof their capabilities and their talent pool.

At the exhibition today, you can take the chance to learn more about how companies are pursuing sustainability practices and benefitting from their green moves. I hope you will be inspired to embrace sustainability practices and make them part and parcel of your business and revenue models.

As more borders continue to re-open in the post-pandemic era, the windows of opportunity are widening as well. This is why in Singapore, we have been very committed to reopening our economy since March. I was so happy to see all the ballrooms being taken up as I came in. Tourism is coming back, and now we are back to more than 55% of our traffic volume for Changi compared to post-COVID level, and I think it bodes well for our business sector. We can capitalise on the momentum and emerge better and stronger. SMEs should seize the chance to build new capabilities and future-proof their companies and their teams, in the new economy, and you will be able to endure and thrive in the post-COVID world

As PM Lee urged in his National Day Rally speech last week to "seize the window of opportunity" and secure Singapore's place in the post-COVID-19 world, let's continue on our sustainable journey together and turn Singapore into a city of green possibilities for future generations.

The view of these SMEs is that having sustainability as a core lens to their business will help to:

- 1. Improve the company's credibility and reputation
- 2. make it easier for them to work with multinational corporations (MNCs) who care about their sustainability goals and their supply chain
- 3. enable them to help build an environmentally and socially responsible Singapore

SMEs are embracing or planning to embrace sustainability goals by integrating environmental, social and governance (ESG) considerations into various aspects of their business. According to this survey, the key ESG-related practices SMEs plan to implement include:

- more efficient use of resources to minimize waste
- use of energy-efficient equipment and technologies.
- clear operational policies and processes such as risk management and financial control

This survey shows a positive outlook on the awareness and adoption of sustainability amongst SMEs.

However, when implementing such practices, we understand that small businesses face challenges such as:

- 1. insufficient skills to identify and execute relevant green initiatives
- 2. inadequate support on areas such as sustainability training, and lack of internal funds to initiate such projects as it may hit profitability in the short term
- 3. potential increase in prices for end customers if they transfer the costs on.

The question is how can SMEs build these capabilities and tap on sustainability opportunities to transform?

With plans for Singapore to reach zero carbon emissions by 2050 and the Singapore Green Plan 2030 already underway, our chambers of commerce and trade associations are fully conscious of the need for our SMEs to move towards more sustainable business practices.

Thus, the trade associations and chambers as well as SME Centers are taking the first steps to create more awareness amongst SMEs of the training programs and solutions available in this area. We will play a critical role in facilitating the sustainability journey for SMEs.



We will not be doing this alone. Together with the support from Enterprise Singapore and partner agencies such as IMDA, SSG, WSG and GC@SBF, there is a network of support readily available for SMEs to tap on to. They have come today to lend their support to the conference and are ready to meet with you today at our exhibition next door.

On that note, I encourage everyone to visit the exhibition, where you will find potential solutions and technologies that may facilitate your sustainability initiatives. More importantly, the exhibition also features some success stories from fellow SMEs who have already embarked on similar initiatives with the support from our SME Centres' Business Advisors.

Thank you for joining us and I look forward to an enriching conference.


























Sri Lanka and Its Provinces Welcome Investors and Tourists



Exploring opportunities in Sri Lanka's Northern Province.

In its ongoing series of dialogues with visiting dignitaries, the Singapore Indian Chamber of Commerce and Industry held a networking and discussion with the Governor of the Northern Province of Sri Lanka, the Honorable Jeevan Thiagarajah, at SICCI Building on 9 September 2022.

Also taking part in the hour-long session was Her Excellency, the High Commissioner of Sri Lanka to Singapore, Madam Sashikala Premawardhane.

The wide-ranging discussion was chaired and moderated by SICCI's Chairman, Mr Neil Parekh.

Giving his welcome remarks, Mr Neil noted that Sri Lanka has been having a bit of a gruelling time and rather sadly.

"First, we all went through it together- the Covid-19 pandemic. And just when things were returning to normalcy in many parts of the world, a second crisis hit Sri Lanka, and this was a double whammy-both political and, as a result, economic too. We all watched the gripping pictures of Sri Lankans exercising their democratic rights in front of the Presidential Palace. Opening remarks by Mr. Neil Parekh at the dialogue with Governor of the Northern Province of Sri Lanka



Her Excellency Ms. P Sashikala, Sri Lanka's High Commissioner to Singapore, The Honourable Governor of the Northern Province of Sri Lanka, Mr. Jeevan Thiagarajah, Senior officials from the High Commission, My fellow Directors, Dear Members of SICCI, Ladies and Gentlemen.

Thank you for joining us this afternoon for this talk and dialogue session about the emerging and growing opportunities in the Northern province of Sri Lanka and the South Asian country.

To give us a first-hand insight, we have none other than the Governor of the province, Mr. Jeevan Thiagarajah accompanied by High Commissioner Sashikala, with whom my colleagues and I have had an opportunity for an engaging session on the current situation in Sri Lanka, which has also led to us deciding to organize this talk for our members.

The Northern Region and Its Governor

One way to create greater awareness is to share more information about the prospects in Sri Lanka, and this is precisely what we hope to do and find out more from both Her Excellency the High Commissioner and our special speaker this afternoon, the Governor of the Northern Province of Sri Lanka, the Honourable Jeevan Thiagarajah.

The governor is here for the second series of the International Conference on Communal Societies which was opened by President Halimah Yacob.

A word about the Northern province and our speaker before I conclude.

The Northern Province consists of five districts namely Jaffna, Kilinochchi, Mannar, Mullaitivu and Vavuniya. The total population of the northern province is around 1.3 million people.

Among the key economic activities in the northern province include agriculture, farming, fisheries, construction, IT services, telecommunications, and energy production.

The Honourable Jeevan Thiagarajah has been the Governor of the Northern Province since October 2021. Mr. Jeevan Thiagarajah has worked in the NGO sector in Sri Lanka since 1984, holding executive positions in several humanitarian and human rights organizations. In December 2020, he was appointed as a member of the Election Commission of Sri Lanka, a post which he resigned in October 2021. That month he was sworn in as the Governor of the Northern province.

We look forward to hearing more about what the northern province can offer to the Singapore Indian business community, and we will be in touch with you and your staff when investment and business opportunities arise.

It has three key objectives or 3 'C"s - Connect (through meaningful conversations), Collaborate (to drive actionable outcomes), and Cultivate (to build internal capabilities of TACs).

OneTAC SG is open to all TACs in Singapore and their secretariat staff and will enable them to share and connect with one another as well as receive the latest updates on policies, initiatives and events from the Government, TACs and other business stakeholders.

Key features of OneTAC SG include the TAC and User Directory, Event Calendar, Communities and Groups, Direct Messaging, Resource Hubs and many more.

OneTAC SG is part of SBF's efforts to enable a strong TAC community and a strong business ecosystem in Singapore.

Attending the event from the Singapore Indian Chamber of Commerce and Industry was its Board member and businesswoman Ms Jayanthi Maniam.

She adds, "It is an excellent initiative from SBF to launch the OneTAC SG App to strengthen partnership and information sharing among TACs. The Funding Programme will be helpful to deepen the capabilities of the secretariat staff to support industry transformation".



Added SICCI's Chairman, Mr Neil Parekh, "As the saying goes, Unity Is Strength. And this is most applicable for the collective efforts that our trade associations and chambers, together with the Singapore Business federation ad Enterprise Singapore have embarked together on the One TAC App project. With digitalization and online processes becoming the order of the day for many of our businesses, small and big, the One TAC app is most timely in particular for SMEs to come on board and take advantage of it for their growth. The Singapore Indian Chamber of Commerce and Industry strongly commends the team that has worked behind this App. It is now our duty and responsibility to make the App known to our members and businesses, and this will be a key task for both the Chamber and its SME Centre, which has a large pool of clients to reach out to and to promote digitalization."

During the launch event, Minister of State Low also engaged the leaders from the trade associations and chambers in a fireside chat, and a key subject was how TACs could help transform businesses besides building their own capabilities.

Ms. Low explained, "I shared about the Forward Singapore exercise and called on the TACs to play an active role in empowering our workers as we refresh our social compact. TACs play a crucial role in the business community through advocacy, bridging and collaboration. The Government will strengthen our partnership with the TACs to help businesses tackle present economic challenges and prepare for the future economy".

Among the highlights of the conference was the release of some key findings from a survey done by the Chamber.


The survey was done between June and August 2022, and ninety percent of the respondents were small and medium enterprises.

SICCI's statement on Manpower Ministry's announcement of the five-year work pass

Singapore's Ministry for Manpower made several announcements on 29 August 2022 to attract talent into Singapore to strengthen Singapore's position as a global hub for talent.

Among the measures, the Government will introduce a five-year work pass that allows foreigners earning at least \$\$30,000 a month to start, operate and work for multiple Singapore companies simultaneously. It will halve the time required for employers to look for locals to fill a position before they can hire foreigners.

Employment Pass (EP) holders working in tech occupations that face a shortage of workers will qualify for a five-year EP, up from the usual two to three years.

The processing time for EP applications will be reduced from three weeks to 10 days.

Responding to the announcements, Chairman of the Singapore Indian Chamber of Commerce and Industry (SICCI), Mr. Neil Parekh said, "Ensuring that Singapore has both local and foreign talent at all levels of the economy and sectors is critical for the nation to remain competitive in the global economy.

The Singapore Indian Chamber of Commerce and Industry (SICCI) welcomes the Manpower Ministry's efforts to attract the best talent for sectors that need them urgently, as spelt out by our Prime Minister during his National Day Rally speech on 21 August 2022.

In these efforts, SICCI is confident that the government will continue to emphasise and exercise its policy of Singaporeans first in encouraging companies to hire top talent when graduating students enter the labour market. In this regard, SICCI urges graduating students to give their best shot for the jobs where talent is much needed for the Singapore economy to flourish, innovate and be competitive.

Among the announcements that would be welcomed by SICCI's members, who comprise many small and medium-sized enterprises, is improvements to the processing time for all applicants for employment passes. Post-Covid, this remained a key concern of our members of the time taken to process EP applications and renew existing ones. MOM's announcement of improving the processing time to within ten business days is excellent news for employers who need to bring in workers on EP.

In the meantime, SICCI urges the government - particularly the Manpower Ministry, to continue looking into the manpower shortage needs of many businesses in the food and beverage sector. Smaller ethnic restaurants continue to need support to remain sustainable. And cater to their clients as much of Singapore's economy has opened up with relaxations to the mask-wearing policy".



SICCI's statement on the launch of the workplace safety code of practice for company management

The Singapore Indian Chamber of Commerce and Industry welcomes the launch of the workplace safety code of practice for company management as announced by the Minister for Manpower, Dr Tan See Leng.

A very important element for Singapore to continue to be an attractive place for our foreign manpower to work is a strong workplace safety and health culture in ALL workplaces, regardless of size.

This is something which many business delegations which meet SICCI's management for discussions speak about and very positively indeed. for the care and concern management has for all its workers, whether local or foreign.

Under such circumstances, every workplace accident that happens is just one too many,

It is all the more tragic when it turns fatal.

On our part at the Singapore Indian Chamber of Commerce and Industry, we will continue to emphasize the importance of workplace safety in our discussions with our members during our regular networking sessions.

This will also be put across by our SME Centre at SICCI when they engage the hundreds of small and medium enterprises on their queries that they may have about doing business in Singapore.

SICCI will also be happy to share any collaterals which MOM may want to distribute to employers on workplace safety and health. These collaterals can be in our four official languages.

At SICCI, we stand ready to do our part with the government and tripartite agencies to achieve zero accidents at our workplaces and to make Singapore a shining example of workplace safety and health to the international community.




